

**Rules and Regulations**  
**for participation in the photo acquisition campaign '#Remembered'**

**§ 1.**

**General Provisions**

1. The Organizer of the Action is the Sybir Memorial Museum with a headquarter at Sienkiewicza 26 Street, 15-085 Białystok.
2. The main objectives of the Action are:
  - 1) creating a photo projection in the final hall of the permanent exhibition at the Sybir Memorial Museum;
  - 2) creating a database of photographs and data of Siberian deportees and their families spread throughout the world.;
  - 3) dissemination of knowledge about Siberia as well as about mass deportations into the depths of the USSR in the 20th century.
3. Details on the course of the Action will be posted on the website [www.sybir.bialystok.pl](http://www.sybir.bialystok.pl).

**§ 2.**

**Participants of the Action**

The Action is addressed to Siberian deportees and their descendants directly or indirectly associated with Soviet deportations into the depths of USSR in the 20th century. By the term 'Siberian deportee' should be taken to mean as a person who was exiled or forced to settle in Siberia.

**§ 3.**

**Rules of the Participation in the Action**

1. The participation in the Action is free and voluntary.
2. Photographs should be taken in accordance with the Organiser's instructions, in particular:
  - 1) the photograph should be taken with a camera or a telephone in a portrait position (vertical);
  - 2) the background for the photo should include characteristic elements with which the photographed Siberian deportee or his/her descendant identifies with;
  - 3) the frame of  $\frac{3}{4}$  person – the lower edge should be below the hip line. The frame should include the wrists.
3. Photographs with the Declaration, in accordance with the specimen attached to these Rules and Regulations, has to be sent in electronic version to the following email address: [wystawy@sybir.bialystok.pl](mailto:wystawy@sybir.bialystok.pl) with the message subject: 'Photo for the Action # Remembered'.
4. The organizer allows the possibility of sending:
  - 1) statements and photos by post (on a pendrive or CD / DVD) or
  - 2) consent / statement and photos via the online form at [www.zapamietani.com](http://www.zapamietani.com) (constituting attachment 2 to these Regulations) or
  - 3) photos in electronic form and the declaration itself by postto the address:

with the note: "Statement and photos for Action # Remembered" or "Statement for Action # Remembered".

**§ 4.**

**Conditions for Participation**

1. The conditions for participation in the Action are: completing and signing the Declaration by the Siberian deportee or his/her descendant (hereinafter referred to as 'Participant') and then sending a scan of the Declaration together with photographs. The Declaration constitutes an attachment to these Rules and Regulations (available on the website [www.sybir.bialystok.pl](http://www.sybir.bialystok.pl) and on the Organiser's Facebook page).
2. At the time of sending the photographs along with the Declaration, constituting attachment 1 to these Regulations, the Participant agrees to publish the photos and his/her name and surname (or of a Siberian deportee, whose data will be provided in the Declaration) on the website [www.sybir.bialystok.pl](http://www.sybir.bialystok.pl) as well as on social media, including on the Organiser's fanpages on Facebook, Tweeter and Instagram.
3. Photographs which do not satisfy the Conditions for Participations referred to in §3, or taken in a manner not in accordance with the posted instructions will not take part in the projection. The Organizer is not obliged to use all sent photographs, but only selected by the Organizer.
4. Adults and persons aged over 13 can take part in the Action Underage participants must be registered by a parent or legal guardian.
5. A notifier who is not a parent/legal guardian declares that he/she has the formal authority to register the child's participation in the Action (including the consents of a parent or a legal guardian for the child's participation in the Action as well as to the processing child's personal data). A notifier declares also that he/she has read and understood these Rules and Regulations and the Information Clause at the end of the Rules and Regulations.
6. Sending the photograph is tantamount to accepting the Rules and Regulations of the Action and to granting of consent of the participant and a parent/legal guardian (or the Siberian deportee) for personal data and photographs processing in materials related to the Action, including on the websites as well as on social media of the Organiser.

## **§ 5.**

### **Copyrights**

1. Participants under the Action will guarantee and transfer copyrights to photographs to the Organiser and allow the Organiser to exercise derivative copyrights to photographs, without the right to wage, on the following fields of exploitation:
  - 1) the use of the photographs on the website: [www.sybir.bialystok.pl](http://www.sybir.bialystok.pl), on the Sybir Memorial Museum's profiles in social media, as well as in the Museum's informational and promotional materials,
  - 2) to place on the market,
  - 3) to preservation and multiplication, using available techniques, including as an artistic installation at the permanent exhibition of the Sybir Memorial Museum,
  - 4) to the public reproduction, display, sharing, exhibition in whole or in parts, using any technique and in any form, in particular in multimedia works and informational and/or educational and/or promotional materials of the Sybir Memorial Museum,
  - 5) storage on computers belonging to the Organiser and making available as part of databases and information services, including via Internet and other data transfer techniques using telecommunications and IT networks,
  - 6) printing without restrictions (also republishing),
  - 7) using, publishing, presenting for promotional, educational and informational purposes.
2. Participants at the time of sending photos with the Declaration authorize the Organiser to commission to third parties to exercise derivative copyrights without the need to send additional declarations.

## **§ 6.**

### **Final Provisions**

1. The Organizer reserves the right to change the Rules and Regulations.
2. The participation in the Action is tantamount to the Participants expressing their consent to the processing of personal data of Siberian deportees and their families by the Organizer and confirming the fulfillment of the information obligation towards them.
3. By joining the Action, the Participant accepts the content of these Rules and Regulations.
4. The final interpretation of these Rules and Regulations belongs to the Organizer. Situations not covered by these Rules and Regulations shall be resolved by the Organizer of the Action.
5. In matters not covered by these Rules and Regulations, are applied the provisions of Polish law, including the Civil Code.
6. Personal data of photographed persons and their parents/legal guardians will be used to carry out the Action (promotions, temporary exhibitions, other actions) and will be published in materials related to the Action.
7. The organizer reserves the right to terminate or cancellation the Action without giving a reason. Information on the termination or cancellation of the Action will be provided in the same way as information on its beginning.

#### **INFORMATION CLAUSE**

Pursuant to Art. 13 (1) and (2) of Regulation of the European Parliament and of the Council (EU) 2016/679 of the 27th of April 2017 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (EU Official Journal of the UE L119, of 2016, p. 1,corr. EU Official Journal of the UE L127 of 2018, p. 2) abbreviated to 'GDPR', the Organizer informs that:

- 1) The controller of your personal data collecting during the Action is the Sybir Memorial Museum with its headquarter at Sienkiewicza 26 str., 15-092 Białystok, Poland, TIN: 5423264915, Polish National Business Registry Number: 366215932;
- 2) Contact with the Data Protection Supervisor is possible at the following email address: [iod@sybir.bialystok.pl](mailto:iod@sybir.bialystok.pl)
- 3) Personal data will be processed in order to carry out the Action and for the objectives specified in the Rules and Regulations of Action which aims to gain photographs '# Remembered';
- 4) personal data will not be disclosed to recipients other than those authorized under the provisions of law and entities to whom the data has been entrusted for processing to Art. 28 GDPR, i.e. to technical and organizational services;
- 5) the data will be processed until the consent is withdrawn;
- 6) the data subject has rights: to demand access to his/her personal data, to demand correction of the incorrect data, to demand deleting his/her data, to object to processing of personal data concerning him/her;
- 7) the data subject has the right to withdraw a consent at any moment without affecting the lawfulness of processing based on consent before its withdrawal;
- 8) provision of personal data is voluntary and is a precondition for the participation in the Action. A failure to provide personal data will make it impossible to participate in the Action;
- 9) in connection with the processing of your Personal Data, you have the right to lodge a complaint to the President of the Office for Personal Data Protection when you consider that processing of your data infringes the provisions of the GDPR;
- 10) the data is not be subject to automated individual decision-making, including profiling.
